



The first day of the long awaited SAIMUN conference starts off in a rather unexpected path. As soon as the session had started and the house had came to order, the Chair began roll call. It was announced that a lot of them had not completed their opening speeches, even worse, some even convicted plagiarism. There was no immediate voice to deny, but notes were passed to the Chair as the delegates justified their reasons not to do their work. This slight disturbance might be enough to affect today's session.

Besides the previous incident, only minor interruptions to the conference were drawbacks, such as Delegate of Malaysia's unnoticed absence, or Iran's tardiness.

Proceeding to the opening speeches, they were all made perfectly. The delegates managed the time and the information with utmost efficiency. The positions of most of the countries were as expected in response to the problems. Peculiarly, the topic of strengthening of security and cooperation in the Mediterranean region was rarely mentioned.

The problem of cyber warfare and security were greatly emphasized, as the delegates stresses their points on terrorism through cyberspace, but mentioned very little regarding security. Concerning the topic on weapons of mass destruction, the majority of the countries seemed to object WMD passionately. One delegate even quoted "mankind should put an end to war, or war will put an end to mankind."

The delegates definitely had intended to deliver particular messages to the House when they gave their opening speeches. China, for example, had claimed their cyber activities are clearly misunderstood and that they are performing legitimate acts. DPRK expressed that the stereotypes about them are very much offensive in their speech on cyber security. Not only were there general claims, there were delegates pointing out other countries directly. Russian Federation accused U.S. of violation of cyber security, and Republic of Korea along with many other delegates accompany DPRK with weapons of mass destruction.

Despite that all there was today was lobbying for the formation of resolutions, tension had already been built. The following days are expected to bring promises of intense and productive debates. On that note, the first day of SAIMUN for GA1 was very successful.

" I'm excited but am also a little bit of nervous."


Is this your first time participating in a MUN conference?

The SAIMUN 2016 is host by our school AmIS. That is why the preparation process for this conference was intense. Everyone involved put a lot of effort to make sure that the conference will be organized and successful.

The SAIMUN 2016 starts with an Opening Ceremony. We are honored to welcome a guest speaker, Ms.Malikat Rufai from Cultural Affairs Officer, to give a speech. The school choir also gave an outstanding performance. The Chairs introduced themselves and the administrator led Chairs and delegates to their rooms.

The Environmental Commission started the first day of the 6th annual SAIMUN with a slow pace. Delegates from forty five countries had the opportunity to introduce themselves and state their positions. The majority of delegates showed their interests in the issue of wildlife trafficking and chemical waste disposal. Furthermore, both developing countries and developed countries suggested that green economy is essential for a sustainable future. In general, all delegates have wished to have a fruitful debate where they will be able to produce practical and effective resolutions that will help the world combat these issues.

During lobbying time, we could easily see the clear tentativeness on first-year delegates' faces as some were not fully prepared. However, the thoughtful chairs of the Environmental Commission eased everyone's stresses by going around to ensure that the delegates are aware of the resolution format and understand how to develop clauses. 6 groups were formed, each coming up with their own resolutions for an assigned issue out of three: combating wildlife trafficking, transitioning to a green economy and, managing the disposal of chemicals and waste. It was great to see how every delegate showed their interests in all three topics with each and every one aimed to create potential resolutions in support of resolving the issues.

Lobby time was busy as delegates rushed to finalize their groups' resolutions in time for approval. However, some delegates were kind enough to spare some of their precious times for short interviews. Regarding the question of the transition to a green economy, the delegate of Japan, Mauritania and Democratic Republic of Korea had the chance to briefly describe their groups' resolutions. The delegate of Japan, who is the main submitter for the resolution, said that the transition to a green economy is a process that requires the help of every nation as it requires high financial costs for some countries. Furthermore, it is crucial for the resolution to be passed since the increase in average temperature has reached the rate of which the Earth's environment may undergo potential harm. Concluding the interview, the delegate of Japan believed that her group's resolution will be supported by most countries as funding, one of the most essential problems, is addressed. With a different approach to the transitioning to a green economy, the delegate of Mauritania and Democratic Republic of Korea based their resolution on raising the community awareness and the change toward green energy.

"A Step Closer to Peace"

AISMUN 2016's Security Council is hosted by Chair Seong Jun Lim and Deputy Chair Yang Woo Seong. The meeting started with the Chairs introducing the debating procedures to the delegates. After the delegates had fully understood the procedures, the House proceeded towards Opening Speeches. At this year's SAIMUN, the Security Council will be debating interesting yet impactful issues that affect the world peace and a nation's security. The issues are the question of situation in Iraq and Syria, the question of threats to international peace and security caused by terrorist and finally the question of the chaotic situation in Liberia.

During the Opening Speech, every delegate shared their most concerned issue to the House and called for solutions to solve those issues. Delegates from France, China, Japan and Uruguay were deeply concerned about the issue of terrorist attacks as well as urged the House to combat against terrorism, especially ISIS.

As the delegate of France stated, "On the behalf of President Francois Holland, France will destroy ISIS." The question of situation in Iraq and Syria as well as the situation in Liberia are addressed by the delegates as well.

While most of the delegates are interested in one particular concern, the delegate of New Zealand took the podium and reminded the entire House that "the purpose of MUN is to establish peace, not to satisfy individual needs." He also stated that all three issues should be addressed equally. The delegate of Spain also stresses the gap between nations will becoming wider, so much that it is to the point where it will be catastrophic if these issues are not seriously addressed.

After every delegate had a chance to raise their concerns, the entire Security Council is now proposing meaningful resolutions that aims achieve world peace.
